Progress Made

First 6 months...

Getting Going

- Created the website and social media channels
- Created IT infrastructure separate from our proxy MediPaCe
- Created a bank account and finances separate from our proxy MediPaCe so that all funds can be clearly tracked, traced, and reinvested in the community
- Created many support resources in the knowledge library and toolkits available to members

Created a solid Governance & decision structure

- Established the board (1 member still to go)
- Established the processes, rules of governance, safeguarding approach, code of conduct, audit-ready practices

Supporting you

- Created the single-contract approach
- Can be legal entity for contracting and reimbursement for those without a formal patient organisation
- Resources, mentoring, and a forum to ask questions

Sharing Best Practice

- Have established knowledge sharing practices with X partners - all leaders in their field improving healthcare and how patients are involved

Raising awareness
